## **Waiver of Claims & Liability Release**

### **Jr. Members**

It is the intent of the undersigned Jr. Member and Jr. Member’s parents or legal guardian to release all CMM entities, members, and each of their respective affiliates, subsidiaries, officers, directors, agents, sponsors, and trainers collectively from any claims or liability to the fullest extent under the law, and to advance that intent the undersigned hereby agrees as follows:

1. We understand and hereby acknowledge that CMM field training presents the inherent risk of serious bodily injury, and our waiver and renunciation of claims in this agreement expressly apply to any bodily injury, damage, or accident that may be suffered by the participant or others resulting from the participant’s participation in CMM field training. \_\_\_\_\_
2. We the undersigned, as a participant and parents or legal guardian of a participant in CMM field training, hereby waive and renounce any claims against CMM, Inc. entities, or any other person participating in CMM field training, including without limitation any claims based on negligence, for any injuring to the participant or others, loss, damage, sickness, accident, delay, or expenses of any kind whatsoever resulting from the participants participation in CMM field training. \_\_\_\_\_
3. We also agree to hold harmless CMM, Inc. entities from any and all claims arising from the equipment or apparatus supplied to the participant for use in CMM field training. \_\_\_\_\_
4. We understand and acknowledge that CMM entities do not guarantee the security or safety of CMM field training sites, or the areas adjacent to and surrounding CMM field training sites, or the areas that participants may traverse on their way to or from CMM field training. We further release CMM, Inc. and its entities from liability from any damage or injury that may occur as a result of the surface or condition of the CMM field training site itself, or the condition of the facilities or equipment used at CMM field training. \_\_\_\_\_
5. We recognize that the participant must obey the instructions of CMM officers, instructors, and other CMM training staff. \_\_\_\_\_
6. We further understand that should any medical services be provided or made available to participant in connection with his/her participation in CMM field training and respective activities , the provision for or availability of which CMM entities do not warrant or make any representation concerning the adequacy or continuation of such medical services, nor can CMM be deemed responsible or held liable for any claims arising out of the provision of such medical services or the failure to provide or continue to provide in connection with CMM field training. \_\_\_\_\_
7. If any portion of this Waiver & Release is declared invalid or unenforceable by a final judgment of any court of competent jurisdiction, we hereby agree that such determination shall not affect the balance of this Waiver & Release, but that this Waiver Release shall remain in full force and effect, as such invalid portion shall be deemed severable. \_\_\_\_\_
